

SCREENING FOR APPROPRIATE ASSESSMENT DETERMINATION

Project reference: LIC230001 NORTH IRISH SEA ARRAY WINDFARM LTD, SITE INVESTIGATIONS OFF THE COAST OF COUNTIES DUBLIN, MEATH AND LOUTH

In accordance with Article 6(3) of the EU Habitats Directive (Directive 92/43/EEC) and Regulation 42(1) of the European Communities (Birds and Natural Habitats) Regulations 2011 as amended ('the Regulations'), MARA has undertaken screening for Appropriate Assessment to assess, in view of best scientific knowledge and the conservation objectives of relevant European sites, if the site investigation works off the coast of Counties Dublin, Meath and Louth, individually or in combination with other plans or projects, would be likely to have a significant effects on any European site.

In accordance with Regulation 42(6) of the Regulations, MARA has determined that an Appropriate Assessment is required as it cannot be excluded on the basis of objective scientific information that the proposed activities, individually or in combination with other plans or projects, may have a significant effect on the following European sites:
