Invitation for public submissions on an application for a maritime usage licence and an appropriate assessment

NISA Limited has applied to the Maritime Area Regulatory Authority ("MARA") for a maritime usage licence under section 117 of the Maritime Area Planning Act 2021 to undertake marine environmental surveys for the purpose of site investigations off the coasts of the Counties of Dublin, Meath and Louth. The surveys will be carried out within the area identified in the licence application in order to inform the location and design of the proposed offshore wind farm and cable route. The surveys will include marine geophysical, hydrographic, geotechnical, benthic subtidal and intertidal ecology surveys, environmental, metocean and archaeological surveys, and water quality monitoring. The licence application is for a period of 7 years.

MARA will then, as soon as practicable, carry out the appropriate assessment determination in accordance with regulation 42 of the European Communities (Birds and Natural Habitats) Regulations 2011. After the determination, MARA will either grant, part grant or refuse the licence application.
