**The Maritime Area Planning Act 2021 and the European Communities (Birds and Natural Habitats) Regulations 2011**

**Invitation for public submissions on an application for a maritime usage licence and an appropriate assessment**

Microsoft Ireland Operations Ltd. has applied to the Maritime Area Regulatory Authority ("MARA") for a maritime usage Licence under section 117 of the Maritime Area Planning Act 2021 to undertake geophysical, geotechnical, environmental (benthic sampling), an archaeological survey and intertidal landfall surveys (including bar probes and 3 Trial Pits). These surveys are proposed to investigate the feasibility of constructing a new subsea telecoms cable system, linking Wales to Ireland, from a landfall on the northwest coast of Wales to a landfall at Kilmore Quay on the southeast coast of Ireland. The surveys are anticipated to take less than 6 weeks in total and will be completed over a 6-month period. The licence application is for a period of 2 years.
