## shop warns pupils of rise in cocaine addiction

The Bishop of Ossory told par-ents of children making their Confirmation in Rosbercon on Thursday of the risks of cocaine and other addictions, inviting the pupils to pledge an oath not to use drugs before they turn 18. Bishop Niall Coll gave a

lengthy sermon to St Canice's, New Ross and Listerlin Sixth

Case pupis and their parents and guardians - in a packed Church of the Assumption in Rosbercon - highlighting the challenges facing parents these days, particularly with the prevalence of technology in our lives.

The Donegal man - who was appointed the role of Bishop of Ossery by Pope Francis in October, 2022, said the pupils the iGen (as in iPad, iPhone) or Gen Z. He said parents are having to contend with many challenges raising their chil-dren in a healthy way, arging the forty or so pupils making their Confirmation to look after their body, mind and spiritual wellbeing.

Bishop Coll said the chal-lenge of addiction to not only

other drugs, looms large, adding that Ireland has the highest in-cidence of cocaine addiction in Europe and the second highest MDMA (ecstasy) usage rates

Quoting research from the European Drug Report 2023 -which found that cocaine use has jumped from 2.9pc in 2016 to 4.8pc in 2022 - Bishop Coll invited pupils to not only take before they turn 18, but added a separate invitation regarding drug use. He said he understood if some of the children eathered would opt not to make the alcohol pledge, but cautioned them about the health dangers of drug use.


Fr Dan Cavanagh, PP of Rosbereon parish, also commented on the challenges facing parparents to oversee the health of their children, adding that schools can only do so much.

Both Fr Cavanagh and Bishop oll acknowledged the many challenges facing children growing up in the 2020s, from depression and rising anxiety levels, recalling simpler, happier times in previous gener

The Department of Environment, Climate and Communications (DECC) has applied to the Maritime Area Regulatory Authority ("MARA") for a maritime usage licence under section 117 of the Maritime Area Planning Act 2021 to undertake marine environmental surveys for the purposes of site investigation in the proposed south coast DMAP (Designated Maritime Area Plan) located off the coast of Counties Cork, Waterford and Wexford, to inform future offshore renewable energy development. The surveys will include geophysical surveys using multibeam echosounder, sub-bottom profiler, surface towed sparkers, mini-air-gun and hydrophones. The surface towed sparker system will be the primary sound source used, with the mini-air-gun utilized when inadequate sub surface penetration is achieved due to local geological conditions Other surveys will include Day Grab or Hammon Grab, drop camera and side scan sonar. The licence application is for a period of 12 months and the survey is expected to take place over a maximum duration of 52 days.

A related Natura impact statement has been submitted with the above licence application.
