1.2	<p>Description of proposed works/activity/event:</p> <p>Proposed benthic surveys in the vicinity of Horse Island, Co. Cork. The purpose of the benthic survey is to provide the information required for a future ecological assessment of a subsea electrical connection from Rossbrin to Horse Island, Co. Cork. Sampling will be carried out within a section of the subtidal within Horse Island Channel and the intertidal at a point to the east of Rossbrin cove and the pier at Horse Island.</p> <p>It is proposed that a maximum of eight (8) subtidal grab samples are collected using a Day Grab with a sampling area of 0.01 m². Samples will be collected from an appropriately licenced survey vessel (RIB licenced under its appropriate class) capable of operating in very shallow water.</p> <p>Three (3) intertidal core stations will be selected on the intertidal sediment areas to the east of Rossbrin point and a further 3 stations will be sampled at Horse Island Pier. At each station 5 x 0.01m² cores will be taken to a depth of 20cm (by hand) for benthic faunal analysis at 1mm mesh size. The samples will be preserved, off site, in buffered 4% w/v formaldehyde solution for subsequent transport and analysis at an NMBAQC certified laboratory. A subsample of the grab contents (approx. 100g) will be retained for granulometric analysis.</p> <p>Sampling will be confined to the area shown in the attached maps (prepared by Declan Daly Civil Engineer, numbered 1-3).</p>


