
PUBLIC NOTICE

The Maritime Area Planning Act 2021 and the European Communities (Birds and Natural Habitats) Regulations 2011

Deep Sea Fibre Networks Ltd has applied to the Maritime Area Regulatory Authority ("MARA") for a maritime usage licence under section 117 of the Maritime Area Planning Act 2021 to undertake marine environmental surveys for the purposes of site investigations to inform the feasibility constructing a new subsea telecoms cable system PISCES which is proposed to link Ireland to EU member states. Specifically, the site investigations will inform the location and design of the cable route and landfall site. It is proposed that the cable will have landfall at Ballyloughane Strand in Galway Bay, prior to traversing Galway Bay a south westerly direction through the Irish maritime area. It is anticipated that the marine geophysical survey and site investigations activities within the Marine Usage Licence area will take less than 6 weeks in total and will be completed over a 6 month period.



Screening for appropriate assessment determination

On 10 October 2024 following screening by MARA under regulation 42 of the European Communities (Birds and Natural Habitats) Regulations 2011 (S.I. 477 of 2011), a determination was made that the proposed maritime usage referred to above <u>requires</u> an appropriate assessment. The determination was made on the basis of objective scientific information which indicated that it cannot be excluded that the proposed maritime usage individually or in combination with other plans or projects, will have a significant effect on a European site. In considering this matter MARA had regard to the following:

- The screening for appropriate assessment report prepared by MARA;
- The environmental report prepared by MARA;
- The application documents submitted by Deep Sea Fibre Networks Ltd which informed the screening for appropriate assessment.

Judicial review of the screening for appropriate assessment determination

The validity of the screening for appropriate assessment determination may be questioned by judicial review under order 84 of the Superior Courts Rules (S.I. No 15 of 1986) in accordance with chapter 8, part 5 of the Maritime Area Planning Act 2021. Any application for leave to apply for judicial review shall be made within eight weeks of the date of this notice.
